72% of the alumni felt that he course structure was helpful for them to Adapt to their career.

5.Industrial Feedback Analysis:

This questionnaire structured with 5 questions and one open end question for suggestions .The feed back is designed in a simple manner to elicit the observations of the industrialists as to Satisfactory and needs to improve.

Seven industrialists gave their feedback during the academic year 2018-19.
