## **ACTION TAKEN REPORT ON FEEDBACK ON CURRICULUM FOR ACADEMIC YEAR 2021-2022.**

The Internal Quality Assurance Cell (IQAC) of Government Degree College for Men, Srikakulam, conducted a comprehensive feedback survey from various stakeholders, including students, faculty, alumni, parents, and employers. The feedback covered several aspects of the curriculum such as content, teaching methods, facilities, and relevance to course objectives. Based on this feedback, the following actions were taken:

**Students:** Students provided feedback on several key areas. They found the syllabus to be comprehensive but highlighted the need for more practical applications. In response, the college introduced more practical sessions and case studies into the curriculum. Students also indicated a need for enhancement in communication skills training. Consequently, workshops and seminars focused on communication and soft skills development were conducted. Although students appreciated the use of Information and Communication Technology (ICT) in teaching, they requested more interactive sessions. To address this, the college increased the use of interactive teaching methods and ICT tools in classrooms. Regarding ICT facilities, students found them satisfactory but suggested more frequent updates and maintenance. The college responded by upgrading ICT facilities and implementing regular maintenance schedules. Additionally, students suggested that the course structure should include more industry-relevant topics. The curriculum was thus updated to incorporate recent industry trends and relevant topics. Lastly, students expressed a desire for more research opportunities, leading the college to encourage student participation in research projects and provide additional support for research activities.


**Faculty:** Faculty feedback highlighted satisfaction with the curriculum design but recommended periodic reviews. To ensure the curriculum remains up-to-date, a committee was established to review and update the curriculum periodically. Faculty members also emphasized the need for continuous professional development. In response, the college organized regular professional development programs and training for faculty. Furthermore, faculty requested more resources for advanced teaching methods, leading the college to procure additional teaching resources and advanced teaching aids.

**Alumni:** Alumni were generally satisfied with the curriculum but suggested updates to meet current industry standards. Their feedback was integrated into curriculum updates to ensure industry relevance. Alumni also expressed a need for more frequent engagement and networking opportunities. To address this, the college increased the frequency of alumni meets and networking events.

**Parents:** Parents provided positive feedback on the curriculum and career prospects but expressed concerns about career guidance. In response, the college strengthened career counseling and guidance services for students. Parents also requested better infrastructure and facilities, prompting the college to improve campus infrastructure and facilities based on the feedback.

**Employers:** Employers were satisfied with the skill set of graduates but suggested more industry exposure. In response, the college introduced internships and industry projects to provide students with real-world exposure. Employers also recommended including more practical and industry-oriented content in the course. The curriculum was revised to incorporate more practical and industry-related modules.

The IQAC's initiative to collect and act upon feedback from various stakeholders has been instrumental in enhancing the curriculum and academic standards of the college. Continuous efforts are being made to ensure that the curriculum remains relevant, comprehensive, and aligned with the evolving educational and industry demands.
